Opportunities for Public Involvement

What is the Proposed Action and Why is it Needed?

The purpose of the proposed action is to efficiently and effectively maintain Department of the Air Force combat capability, mission readiness, and homeland defense. Beddown and operation of the F-15EX and F-35A at Air National Guard locations would represent a major step toward this goal. The NGB proposes to beddown one squadron of F-15EX aircraft at two of three alternative locations and one squadron of F-35A aircraft at one of four alternative locations. The F-15C/D fighter aircraft need to be replaced due to attrition, decreasing service life, and because new F-15C/D aircraft are no longer being manufactured.

As part of the proposed action, the NGB would implement necessary construction and modification projects to successfully beddown the aircraft at the selected installations. Additional personnel would be required to support the beddowns. Approximately 100 personnel would be needed for each alternative location for the F-15EX beddown and approximately 80 personnel would be needed for the F-35A beddown. The proposed action would not require changes in Special Use Airspace attributes, volume, or proximity.

The four alternative locations for the proposed action are:



Barnes Air National Guard Base (ANGB) at Westfield-Barnes Regional Airport, Westfield, Massachusetts:



Fresno ANGB at Fresno Yosemite International Airport, Fresno, California;



Naval Air Station (NAS) Lemoore, Lemoore, California*; and



NAS Joint Reserve Base New Orleans, Belle Chasse, Louisiana

The National Environmental Policy Act

The National Environmental Policy Act (NEPA) is our national charter for making informed decisions based upon potential environmental consequences. NEPA requires all federal agencies to take a good-faith, hard look at potential environmental consequences of a proposal before making a decision. The NGB is preparing a detailed study that analyzes the potential environmental impacts of this proposal.

Public Involvement

Public involvement is an integral part of the Environmental Impact Analysis Process, which requires full disclosure of potential environmental impacts to the public and encourages public involvement. The public has an important role in providing input during this process to help the NGB make more informed decisions about implementing this proposal. The first opportunity for public involvement is the process called "public scoping." The scoping period for this Environmental Impact Statement (EIS) began with publication of the "Notice of Intent" in the Federal Register on July 19, 2022, and will formally extend through September 2, 2022.

Written Scoping Comments are Welcome!

Please send written comments by the end of the public comment period, September 2, 2022, to ensure that your concerns are addressed in the Draft EIS. Nevertheless, we will welcome your comments throughout the entire Environmental Impact Analysis Process. Comments received after the close of the public comment period will be reviewed but may not be specifically addressed in the Draft EIS. Written comments may be submitted by:
